Issues were raised by members of the public concerning the following:

- 15/08633/FUL concerns about the removal of trees and the erection of a fence on top of a wall.
 Ownership of the trees was questioned.
- Issue of an overgrown hedge on Chestnut Road. Cllr E Pope advised that Wiltshire Council contractors are due to cut hedges in Oct/Nov.
- 15/09153/FUL concerns about the height of the wall not the same as specified in the application.
