

**WILTSHIRE COUNCIL**

**ROAD TRAFFIC REGULATION ACT 1984**

**THE COUNTY OF WILTSHIRE (B4069, VARIOUS PARISHES)**  
**(WEIGHT RESTRICTION) ORDER 2017**

The Council of the County of Wiltshire in exercise of its powers under Sections 1, 2 and 3(2) of the Road Traffic Regulation Act 1984 ("the Act") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order.

1. Save as provided in Article 3 of this Order, no person shall, other than with the permission of a Police Constable in uniform or of a Traffic Warden, use, or cause or permit to be used, any heavy commercial goods vehicle in excess of 18 tonnes maximum gross weight in such a way that it proceeds along the length of road specified in the Schedule to this Order.
2. The Council of the County of Wiltshire is satisfied that: -
  - (a) for preventing damage to the road or building on or near it;
  - (b) for preserving or improving the amenities of an area by prohibiting or restricting the use on a road or roads in that area of heavy commercial vehicles

it is requisite that Section 3(1) of the Act should not apply to this Order

3. Nothing in Article 1 of this Order shall make it unlawful for any heavy commercial vehicle to proceed along the length of road specified in the Schedule to this Order if the vehicle is being used: -
  - (a) for or in connection with the conveyance of persons, goods or merchandise to or from any premises situated on or adjacent to the road;
  - (b) an 'authorised vehicle' and is travelling to and from an 'operating centre' in, or adjacent to the road;
  - (c) in connection with any building operation or demolition in or adjacent to the road, the removal of any obstruction to traffic in the road, the maintenance, improvement, or reconstruction of the road, or the laying, erection, alteration or repair in or adjacent to the road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of telecommunications apparatus as defined in Schedule 2 of the Telecommunications Act 1984;
  - (d) in the service of a local authority in pursuance of statutory powers or duties;
  - (e) in the service of the Police Authority, the Fire and Rescue Authority or Ambulance Service in a case of emergency;

(f) being used for the purpose of agriculture in connection with land in, or adjacent to the road.

4. In this Order:-

“Authorised Vehicle” means a vehicle used under an operating licence

“Operating Centre” has the meaning defined in the Goods Vehicles (Licensing of Operators) Act 1995

5. This Order shall come into operation on 3<sup>rd</sup> July 2017 and may be cited as The County of Wiltshire (B4069, Various Parishes) (Weight Restriction) Order 2017.

Length of Road in the Parishes of Sutton Benger, Christian Malford, Dauntsey and Lyneham and Bradenstoke subject to an 18 tonnes Weight Restriction
