Minutes of the Meeting of the Parish Council

Those present were noted as Cllrs N Roynon (Chair), R Gaunt, J Campbell, D Errington, C Mansfield and D Spencer, and L Roslyn, Parish Clerk, 4 members of the public and Ward Cllr H Greenman.

059⁽²³⁾ Apologies and Reasons for Absence.

Apologies were received from Cllrs. B Carter (unwell) and L Craig (holiday).

060⁽²³⁾ Declarations of Interests from members regarding the agenda.

No declarations of interest were received.

061⁽²³⁾ Public Forum Session

Residents of Seagry Road were present for an update on the traffic calming application to LHFIG – it was **agreed** to move the item up the Agenda.

c) **Seagry Road Traffic Calming** – Cllr C Mansfield reported on the results of the Seagry Road speed survey carried out in June, which showed that the average speed of vehicles was 37mph. She attended the LHFIG Meeting on 6 July 2023 where it was agreed that K Rose, Principal Engineer Manager would attend a site meeting to discuss options for traffic calming. She also reported that there was a lack of funds available to LHFIG and that the Parish Council may need to contribute a higher amount. Following a brief discussion, she agreed to try and find out more about whether the painted line on Seagry Road was a footpath and whether it could be enhanced.

062⁽²³⁾ Minutes for Approval

It was <u>resolved to approve</u> the minutes of the Parish Council Meeting held on Wednesday 14 June 2023 and they were duly signed by the Chair.

- a) It was <u>resolved to approve</u> the monthly accounts statement and new invoices totalling £1,908.48 for online payment.
- b) It was <u>resolved to approve</u> the purchase of a 6' Tripod Ladder with adjustable legs for the SID Volunteer Team to use when moving the device at £319.00.
- c) It was <u>resolved to approve</u> the purchase of a kneeling chair for the Clerk, at a cost of £124.58 being a 50% share with CMPC also paying 50%.

Cllr R Gaunt asked all Councillors to respond to the planning application circulated by the Clerk by email.

No update received – the team are still working on the Reg.14 responses.
